In view of the above issues and sources, the Rome office of ITALBANGLA Coordination and Development Association was visited and the following information was collected and reviewed:

**a) Legal basis for operating in Italy:**

Ass. Coordinamento ITAL BANGLA E SVILUPPO The organization was registered under the Rome Court on 18/03/1993. The organization is a listed institution of the Italian Chamber of Commerce.

**b) Approval of Italian Government:**

The organization has permission to conduct business activities in Italy. The organization has already received approval to bring in workers through two projects under the Italian Ministry of Labour and Social Policies. Details of the projects have been published on the website of the Ministry of Labour and Social Policies.

**c) Approved project information:**

i) Bangla Lux Project- The project has been approved by the Italian Ministry of Labour and Social Policies on 28 October 2024. Through this project, 60 workers will be able to come to Italy from Bangladesh. Through this project, there is an opportunity to bring skilled workers in the mechanics, machine operation and management categories.

ii) Bangla Dream Project- The project has been approved by the Italian Ministry of Labour and Social Policies on 26 February 2024. Through this project, 100 workers will be able to come to Italy from Bangladesh. Through this project, there is an opportunity to bring skilled workers for the garment and heavy industries.

**d) Previous experience of the organization and benefits of incoming employees:**

Currently, there are 160 workers approved by the Italian Ministry of Labour and Social Policies through 2 projects. It is learned that the organization is conducting the Pre-departure Professional Linguistic Civic Security Training Program in Bangladesh with the aim of bringing workers to Italy through language and other skills training. It has already confirmed that 26 Bangladeshi workers have arrived in Italy to work as welders and linking operators. Some of the arriving workers were contacted by the embassy.

**e) Information regarding salaries, allowances and other benefits of employees:**

The salary for work in Italy is determined according to the national wage tariff policy CCNL. Medical and other insurance are available from government services such as INPS, INAIL, etc. Therefore, employees coming through the organization will be considered eligible for all the benefits determined by the Italian government under the employment contract.
