**Training Program** Implementation, The necessary guidance discussions were held between the Bangladesh government and relevant stakeholders for the purpose. European Talent in Bangladesh [Language training and technical training](#) are required for the implementation of the partnership program . Although there are sufficient technical training centers under the government of Bangladesh, Bureau of Manpower and Employment (BMET) , Ministry of Youth and various private organizations, there is no such institution for Italian and European language training . In light of this, in 2022, based on the instructions of the Italian Ministry of Labor, the ItalBangla Association [established an Italian language school in Bangladesh](#) in collaboration with its partners in Bangladesh . On March 8, 2024, [SIENA UNIVERSITY of Italy in Bangladesh](#) The first Level - A1 exam in Italian was held under the supervision of the ItalBangla Association and the Italian Embassy . In 2024-2025, the ILO will provide training to 3,000 workers in Bangladesh with 3 million euros in financial assistance from the European government. The much-discussed **European-Bangladesh Talent Partnership Program**, is already underway in Italy and Europe through a bilateral agreement with the Bangladesh government.

[BANGLA DREAM](#) The project **is officially recognized as a pilot project under the European Talent Partnership Program of the Italian government.** As the implementer of which we ItalBangla association are proud partner. We are basically [Talent Partnership with Bangladesh: launch of a new program to boost labour mobility - European Commission](#) working to widely spread the Job Mobility and Talent Partnership program from Bangladesh to Europe .

In Bangladesh , through tireless efforts in 2022-2023, the first Italian language school was established in Bangladesh, through which [a project called Bangla Dream was launched with the aim of providing Italian language and technical training to 100 workers by 2024.](#) Accepts In 2024, with the approval of the Italian Ministry of Labor, the training program in Bangladesh started on March 8, 2024 and the job placement process is successfully underway after completing the training in this project. As of April 2025, 26 workers have joined work in Italy. The job placement process for the remaining 74 workers is ongoing.

A total of 100 Bangladeshi workers have been approved to come to Italy for work under the [Bangla Dream Project](#) .

[80 Garments Linking Operator](#) and [20 Welder](#) have started their technical training in Bangladesh with italian language training program.

Italbangla is currently working as a partner in these two projects with the approval of the Italian government for the Pre departure Professional – Linguistic – Civic – Security Training Program BANGLA DREAM project for 100 workers and BANGLA LUX for 60 workers before their departure. Out of the 100 workers under the Bangla Dream Project, 26 workers have already arrived in Italy and joined various companies.

Currently, the second project, Bangla Lux, has been approved for another [60 electricians](#).

## **v) Worker Recruitment process:**

To apply for project approval through Pre Departure Linguistic – Professional - Civic – Security Training in Italy, the following steps must be followed;;

- 1) Collection of demand letters of workers by the employer;
- 2) Selection of workers;
- 3) Determination of training partners;
- 4) Sending proposal for approval to the Italian Ministry of Labor;
- 5) Obtaining consent from the Italian Embassy in Bangladesh;
- 6) Starting language and technical training after receiving project approval;
- 7) Providing language and technical training tests and certificates;
- 8) Application for work permits and visa approval by the employer (nulla osta application)

- 10) Collection of BMET clearance in Bangladesh
- 11) Purchase of air tickets and joining the workplace in Italy.

## vi) Regarding salaries of potential sectors and sector-based employees :

There is a huge demand for workers in almost all sectors, including semi-skilled/skilled construction, transport, tourism, agriculture workers and high-skilled IT, in Italy and 29 European countries, including the Balkan countries. There is a demand for at least 10 million workers in 2025. In the next five years, 50/70 million workers will be unemployed in the European Union.

**Employment conditions:** All jobs in Italy are subject to the national wage tariff policy CCNL, set by the government. It is mandatory for the employer to guarantee the residence of each worker in order to obtain a visa and work permit. [Contratto CCNL Commercio: levels, tabelle retributive, aumenti 2025](#)

1. Age of the worker: 18-45 years
2. Contract duration: initially for at least 1 year, subsequently renewable for a permanent long term.
3. Working hours: at least 8 hours a day (160 hours a month) according to CCNL Italian labor law.
4. Contract in the sector: required by CCNL and in accordance with the framework of Italian labor law.
5. Salary: according to Italian CCNL standards according to the profession.

Salary:

6. Unskilled / semi-skilled: internship 4 - 6 euros per hour 640 to 960 euros per month
7. Skill category: 10 - 30 euros per hour (1,600 - 4,800 euros per month)  
(Minimum wage at social security level guaranteed by Italian labor law)
8. Overtime: according to CCNL standards.
- 2 festive bonuses per year: according to Italian CCNL standards.
9. Insurance: to be provided by the company/employer.
  - a) Medical: INPS (National Social Security Insurance)
  - b) INAIL (Insurance against accidents at work)

- All terms of employment contract in accordance with the Italian Labor Code CCNL.
- Housing: Employees will receive suitable housing on rent sharing\* terms.
- Air tickets: At the employee's own expense.
- Permanent residence permit in Italy and the opportunity to obtain citizenship after 10 years.

### Requirements for employee selection:

1. Proof or certificate of employment in the country or abroad.
2. Prepare CV with passport and send video CV while working.
3. Participate in FAD (Formation at Distance) online Italian language Level A1 language course.
4. Participate in FAD (Formation at Distance) online civic education and work safety training.
5. The time to receive the training certificate is 3-6 months.
6. Once the certificate is received, the work permit and visa process will begin. Processing time is 3 months.
7. Flight to join the job: It will take 6-9 months.
